If the NAR New Member mandates have been met, the application fee is \$25.00. Applicants applying for Secondary Membership (GAR and NAR Dues and Fees have been paid for 2010 to another Board/Association), add \$25 for transfer fee. Agents and Licensed Assistants have 30 days to join a Board after placing their license with a member company. A Late Fee of \$25/month will be imposed after 30 days. HCBR accepts credit card payments (Visa, Discover and Mastercard) - \$8 processing fee.
